* For NW1, NW2, NW3 and Element videos **marking** means hides and distractors are indicated with arrows until they're found. For Elite videos hides and distractors will be shown for a few seconds at the beginning of the search and at each camera position change.

FAQs

I know I'm going to want my videos—what should I do?

Email me at Karen@FidoPhotography.net **before** the trial.

It's also possible to sign up at the registration table when you check in on trial day, but it's easy to forget in the scramble to get checked in so it's best to email me. There's no obligation to buy your videos no matter when or how you sign up.

When and how do I pay for my videos?

At the end of your trial day you can pay with cash, a check made out to **Fido Photography**, a credit card or you can request a Paypal invoice.

After the trial you can contact me by email to order your videos or you can reply to the email I send on Wednesday or Thursday after the trial.

How long does it take to get my videos?

Videos that are paid for at the trial are delivered within **a week** of the **end** of the trial. If you order after the trial, it depends on how many orders there are in the editing queue, but generally the delivery time is less than five days from when your payment is received.

Each video is edited for brightness and sharpness and then the hides and distractors are marked. They aren't available the day of the trial.

If you don't have your download link within a week please **check your spam filter** and if the email isn't there contact me right away.

How do you deliver the videos? Should I bring a flash drive to the trial?

You'll receive an email link to your files from a file transfer service so you can download them to your computer, tablet or phone.

If you have trouble downloading files from the internet and would like me to mail you a flash drive then bring one to the trial and I'll mail it to you with your videos on it. Mailing service is \$5. 4GB flash drives are \$5 if you'd like me to provide one for you.

What is a marked video?

A marked video is one where the hides and distractors are indicated with small colored arrows. They're a good visual indicator for seeing what your dog might be paying attention to during the search. It's also easier for non-nose work people to see what your dog is doing if you share your videos.

Do you video all the elements and all the competitors?

I video all competitors and all non-interior elements (exteriors, containers, vehicles) as space allows. The NACSW doesn't allow any photography in interior search areas.

How long do I have to decide if I want to buy my videos?

I keep the videos for at least a week after the trial, but they take up a tremendous amount of memory so I delete them before I shoot the next trial.

Can I post my videos on Facebook?

Yes, definitely! For sharp videos on Facebook link to YouTube rather than uploading directly to Facebook.

Can I get my videos without running time?

Sure, just let me know when you order.

If there are multiple views for a search can I get them as separate videos?

Yes, let me know that that's your preference when you order.

What do you do with my email address?

I use it to send you a link to your videos once they're edited and converted to mp4 files.

If you haven't already placed an order, I send you an email after the trial letting you know the videos are available and how you can purchase them. I don't save email addresses from one trial to the next and I don't send spam.
